
FY20 ALLOCATION Teacher Pay Raise \$14,495,354 <u>\$511,464</u> \$15,006,818

Highlights (2020-2021)

- MAEP Reduction due to enrollment decline/not fully funded
- Health insurance increase estimated \$175,000
- Additional funding for Technology CARES and EDLA
- Pay increase for all Cafeteria Employees
